Use

Allowed is only the application of this product as adjuvant with plant protection agents.

Direction for use

Elasto G5 is a polyglycerol based adjuvant. Elasto G5 improves the foliar uptake of several active ingredients. Elasto G5 also improves the wetting of 'difficult-to- wet' leaf surfaces. As a result, Elasto G5 can enhance the performance of several fungicides, herbicides and growth regulators.

Important Each direction for use on the label of the plant protection agent has to be followed and has priority over the text on the label of Elasto G5. Elasto G5 is a mild, quite crop friendly product. If one starts with an application not listed on this label we recommend using Elasto G5 on a small area before starting with large scale applications.

Applications

Herbicides

Elasto G5 can improve the performance of several herbicides including glyphosate, nicosulfuron and rimsulfuron.

Growth regulators

Elasto G5 can improve the performance of chlormequat (for example in poinsettia) and daminozide (Hydrangea, Kalanchoe, Petunia, Sutera, Campanula, Platycodon, sunflower, Viola cornuta, potted chrysanthemum, Dahlia, Dahlietta, Solanum rantonettii and lavender). As a result the application rate of the growth regulators can be reduced by 40 to 50%.

Preparation of spray solution

In case present, follow the instructions on the label of the crop protection agent. Our recommendation is to add Elasto G5 as the last step in the preparation of the spray solution. Elasto G5 can be dissolved easily in the spray solution by gently stirring the solution.

Advice is to include Elasto G5 at 250 ml per 100 liter (0.25% v/v). Depending on the application, a lower (0.125%) or a higher concentration (0.5%) can be used. We recommend conducting a test treatment on a small area when one wants to include Elasto G5 at 0.5%.

Storage

Keep well closed in original container.
